IMPORTANT SAFETY INFORMATION

Read the safety instructions before first use of this product. This conferencing phone is not designed for making emergency telephone calls when the power fails. Make alternative arrangements for access to emergency services.

WARRANTY AND SERVICE

Limited Warranty

Konftel guarantees to the end user (the "Customer") that this product will be free from defects in workmanship and materials, under normal use and service, for a period of two (2) years from the date of original purchase from its authorized distributor. Konftel's sole obligation under this express warranty shall be, at Konftel's option and expense, to repair the defective product or part, or deliver to the Customer an equivalent product or part to replace the defective item.

All products that are replaced will become the property of Konftel. Replacement products or parts may be new or reconditioned. Any replaced or repaired product or part carries a ninety (90) days limited warranty or the remainder of the initial warranty period, whichever is longer. Products returned to Konftel must be sent prepaid and packaged appropriately for safe shipment. It is recommended that the package is insured or sent by a method that enables tracking of the package.

Responsibility for loss or damage does not transfer to Konftel until the returned item has been received by Konftel. The repaired or replaced item will be shipped to the Customer, at Konftel's expense, not later than twelve days (12) days after Konftel has received the defective product, and Konftel will retain risk of loss or damage until the item has been delivered to the Customer.

Exclusions

Konftel shall not be liable under this limited warranty if examination and tests of the returned product reveal that the alleged defect or malfunction in the product does not exist or results from:

- Failure to follow Konftel's installation, operation or maintenance instructions.
- Unauthorized product modification or alteration.
- Unauthorized use of common carrier communication services accessed through the product.
- Abuse, misuse, negligent acts or omissions on the part of the Customer and persons under the Customer's control; or
- Acts of third parties, force majeure, accident, fire, lightning, power surges, outages or other hazards.
