

Setting up

Connections



Note:

- Use only the supplied Panasonic AC adaptor PQLV219E.
- The AC adaptor must remain connected at all times. (It is normal for the adaptor to feel warm during use.)


Battery installation/Battery charge

Important:

- Use the supplied rechargeable batteries. For replacement, we recommend using the Panasonic rechargeable batteries noted in the base unit's User Guide on the Panasonic Web site. See page 1 for Panasonic URL.
- Wipe the battery ends (⊕, ⊝) with a dry cloth.
- Avoid touching the battery ends (⊕, ⊖) or the unit contacts.
- Confirm correct polarities (⊕, ⊝).
- USE ONLY Ni-MH batteries AAA (R03) size.
- Do NOT use Alkaline/Manganese/Ni-Cd batteries.

Charge for about 6 hours.

When the batteries are fully charged, the charge indicator goes off.



Note:

 If the batteries are fully charged, but the operating time seems to be shorter, clean the battery ends (⊕, ⊖) and the charge contacts with a dry cloth and charge again.

Registering a handset to the base unit

1 Base unit:

■KX-TGP500 series

Press and hold [ALL] for about 4 seconds until the STATUS indicator flashes in red.

■KX-TGP550 series

Press and hold [ALL] for about 4 seconds until the registration tone sounds and the STATUS indicator flashes in red.

- If all registered handsets start ringing, press the same button to stop. Then repeat this step.
- The next step must be completed within 90 seconds.

2 Handset:

[OK]

- 3 Wait until "Enter Base PIN" is displayed. → Enter the base unit PIN (default: "0000"). → Press [OK], then wait until a long beep sounds.
 - If you forget your PIN, contact your phone system dealer.



Wall mounting

- 1 Drive the screws (not supplied) into the wall.
- 2 Mount the charger (1), then slide it down (2) and to the right (3) until it is secure.



Note:

 Make sure that the wall is strong enough to support the weight of the unit.

WARNING

Power connection

- Completely insert the AC adaptor/power plug into the power outlet. Failure to do so may cause electric shock and/or excessive heat resulting in a fire.
- Regularly remove any dust, etc. from the AC adaptor/power plug by pulling it from the power outlet, then wiping with a dry cloth. Accumulated dust may cause an insulation defect from moisture, etc. resulting in a fire.
- Unplug the product from power outlets if it emits smoke, an abnormal smell, or makes an unusual noise. These conditions can cause fire or electric shock.
 Confirm that smoke has stopped emitting and contact your phone system dealer.

Installation

- To prevent the risk of fire or electrical shock, do not expose the product to rain or any type of moisture.
- Do not place or use this product near automatically controlled devices such as automatic doors and fire alarms. Radio waves emitted from this product may cause such devices to malfunction resulting in an accident.

Operating safeguards

 The use of excessive sound volume through earphones, headphones, or headsets may cause hearing loss.

Installation and relocation

 The AC adaptor is used as the main disconnect device. Ensure that the AC outlet is installed near the product and is easily accessible.

Battery

- We recommend using the supplied batteries or additional/replacement batteries noted in the battery information section of the base unit's User Guide on the Panasonic Web site. See page 1 for Panasonic URL. USE ONLY rechargeable Ni-MH batteries AAA (R03) size.
- Do not mix old and new batteries.

- Do not open or mutilate the batteries. Released electrolyte from the batteries is corrosive and may cause burns or injury to the eyes or skin. The electrolyte is toxic and may be harmful if swallowed.
- Exercise care when handling the batteries. Do not allow conductive materials such as rings, bracelets, or keys to touch the batteries, otherwise a short circuit may cause the batteries and/or the conductive material to overheat and cause burns.
- Charge the batteries provided with or identified for use with this product only, in accordance with the instructions and limitations specified in this manual.
- Only use a compatible charger to charge the batteries. Do not tamper with the charger. Failure to follow these instructions may cause the batteries to swell or explode.


