Attaching the Base Stand


The base stand can be attached to the SoundPoint® IP 650 in one of two ways:

Deskmount Method:

Connect all cables.



2) A lign tabs of base stand as shown.








Wallmount Method:

- D On the back of the phone, remove the wallmount tab located behind the hookswitch. Reposition it so that the end tab is facing up. This will ensure that the handset remains in place within the cradle in a wallmount position.
- 2 Fasten the wallmount unit to wall using wall anchors (not included). When wallmount is secured and all cables are connected, snap the SoundPoint® IP 650 into place.
