# VIP-412-DF IP ONE-WAY FLUSH MOUNT SPEAKER/CLOCK ASSEMBLY

# INTRODUCTION

The VIP-412-DF One-Way IP Wall Speaker with Clock enables voice access to a single zone of one-way paging over an IP-based LAN/WAN. This allows a page zone extension anywhere on the network. The speaker level is electrically adjusted during set up. Clock synchronization is initiated via connection to a factory preprogrammed time server. The enclosure is made of steel with a durable gray powder coated finish. The color of the enclosure can easily be changed to match any decor. A detachable black clothe grille is included. Power is provided to the VIP-412-DF via a Power over an Ethernet switch meeting the 802.3af specification.

#### **MOUNTING**

Remove the screw holding the mounting bracket to the enclosure. Mount the bracket using appropriate hardware such as #8 pan head crews. After making the required connections, reattach the enclosure to the mounting bracket

#### **Network Connection**




Figure 1. Connections

The VIP-412-DF has one CAT-5 RJ-45 network connector on the rear panel. Use the supplied CAT-5 patch cable to connect the VIP-412-DF to an Ethernet switch. (See Figure 1)
